Subject: - Amendment in Rule 4 (ii) at page 76 of P.U. Calendar Volume -III of 2016.

Sir/Madam,

In terms of the recommendations of the committee dated 08.01.2018 regarding the issue of posts of Deputy Registrar, approved by the Syndicate vide Paragraph 33 of its meeting held on 30.03.2018, 21.04.2018 & 29.04.2018, the Hon'ble Vice-Chancellor has approved that the amended Rule 4 (ii) at page 76 of P.U. Calendar Volume -III 2016 be taken into consideration for implementation w.e.f. 06.09.2018 i.e. the date of final decision of the High Court of Punjab & Haryana at Chandigarh in LPA-53-2017 (O&M) (Panjab University and another versus Dharam Paul Sharma). The amended rule reads as under:-

Existing Rule	Amended Rule
The ratio of filling up the posts of Deputy Registrars by open selection and seniority-cummerit be 50:50. 25% of the 50% of the promotional posts be filled through seniority-cummerit and the remaining 25% through selection but only from amongst the internal candidates.	 (i) The 50% posts of Deputy Registrar shall be filled in by the promotion on the basis of seniority-cum-merit. (ii) 25% of posts of Deputy Registrar shall be filled in by open selection through advertisement as per approved qualifications and the remaining 25% posts of Deputy Registrar shall be filled in by internal selection amongst the in-service Assistant Registrars having one year experience of working as Assistan Registrar (officiating as well as substantively), irrespective of prescribed qualification.
The qualification for the post of Deputy Registrar to be filled by selection is as under: xxx xxx xxx xxx	No Change
