Dear Sir/Madam,

May I draw your kind attention to Section 3(l)(h) of the Panjab University Act-1947, whereby Six Ordinary Fellows shall be elected this year by the Faculties of this University.

As per Regulation 23 appearing at Page 70 of Panjab University Calendar, Volume-I, 2007, Six Fellows shall be elected by the Faculties. Of these, one shall be elected by each of the Faculties of Arts, Languages, Science, Medical Sciences and Law and one shall be elected by the remaining Faculties combined, viz., Business Management & Commerce, Dairying, Animal Husbandry & Agriculture, Design & Fine Arts, Education, Engineering & Technology and Pharmaceutical Sciences.

The Fellows to be elected by the Faculties of Arts, Languages and Science, shall be persons working as teachers in the University Teaching Departments or Institutions affiliated to the University. Only such persons shall be eligible to seek election from the Faculties as are residing within the State of the Punjab or Haryana or Himachal Pradesh or Union Territory of Chandigarh or Delhi.

As per Regulations, nomination of a candidate has to be made by a member of the Faculty or the Faculties concerned, supported by another member of the Faculty or the Faculties concerned and forwarded to **Professor Karamjeet Singh, Returning Officer & Registrar, Panjab University, Chandigarh-160 014 (By Name), by registered post or delivered to him personally during office hours; on a working day, against a receipt in writing, so as to reach office not later than 4.00 p.m. on 4th August 2020 (Tuesday).** The candidate proposed shall sign his/her proposal form in token of his/her consent to stand for election. The sealed envelope under registered cover should be delivered during office hours on any working day, against a receipt in writing, so as to reach not later than 4.00 p.m. on 4th August 2020 (Tuesday). Nomination Forms received after this date and time will be invalid even if they are delivered late by post office.

The election shall take place at a meeting of the Faculty concerned or group of Faculties on 24th August 2020 (Monday). A list of candidates seeking election will be sent to all the members of the Faculty concerned or group of Faculties, in due course.
