OFFICE ORDER

In pursuance of circular No. DC/DN/F-20/2021/7050 dated 01.04.2021 issued by the office of the Deputy Commissioner, Chandigarh, the Vice Chancellor has passed orders that:-

- (i) the minimum wages of the following categories of the Daily wage workers engaged on D.C rates in Panjab University, Chandigarh and its Regional Centres, Constituent Colleges, Guest Houses etc. be revised as noted against each:-

- (ii) the minimum wages of all similar categories posts viz Common Room Attendant, Ground man, Ball Boy, Mason & Lineman in same pay i.e. D.C Rate @ 15003/- p.m. (fixed) be revised to Rs. 16053/- p.m. (fixed) of daily wage workers engaged on D.C. rates in Panjab University, Chandigarh and its Regional Centres, Constituent Colleges, Guest Houses etc.

Further the Vice Chancellor has ordered that all the Daily wage staff, who are getting salary at D.C. rates be paid arrear (if any) as per revised D.C rates w.e.f 01.04.2021.

Note: The Board of Finance vide its agenda item no. 17 dated 21.02.2012 has authorized the Vice Chancellor to adopt the Notification issued by the Deputy Commissioner, U.T. Chandigarh from time to time w.r.t minimum rate wages to certain categories of Daily wage/Contract basis employees.
